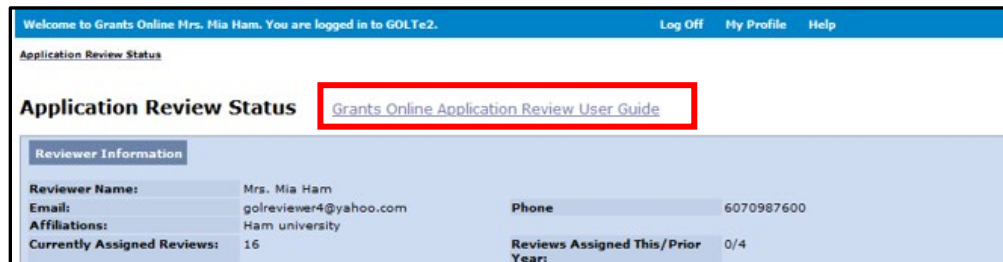

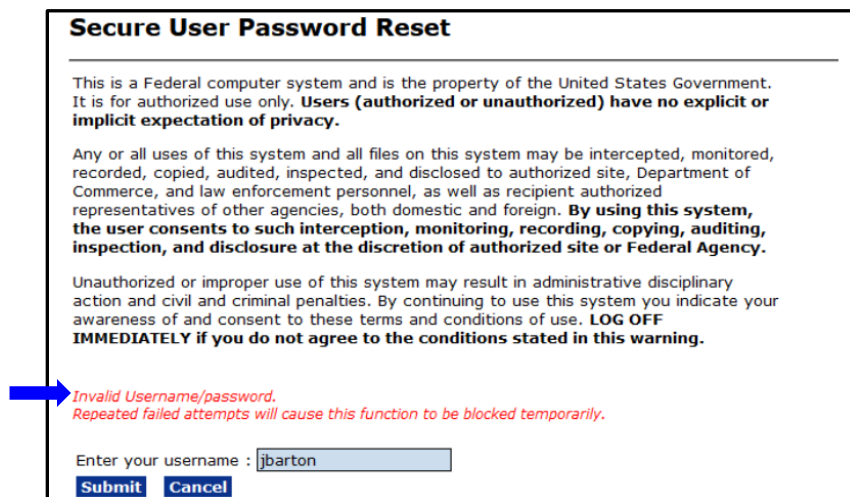

Global

1. The Guidance link to the Application Reviewer's Quick Reference Guide when logged into Grants Online now navigates the user to the correct document. This document was last updated on April 2022. [JIRA: NGO-1249]



2. The start date and the end date data elements on the Review Event, Competition and Amendment pages are now validated to ensure they conform to the mm/dd/yyyy format. [JIRA: NGO-1316]
3. When double quotes or single quotes are entered for the Statutory Authority and Project Description/Abstract (PO Checklist); or the Project Title and Project Description (Amendment), the invalid characters will be removed from the data elements. [JIRA: NGO-1317]
4. When an inactive user attempts to reset the password for his/her account, a message is displayed that the username/password is invalid. [JIRA: NGO-1322]


