1. AK2205725; C/P Cape Horn – Owner Cape Horn Vessel, LLC and Operator Peter Pack were charged jointly and severally under the Magnuson-Stevens Fishery Conservation and Management Act (Magnuson-Stevens Act) with fishing in a closed area. A \$26,801 NOVA was issued.

- 2. NE2201434; F/V Capt'n Lee Owner Hilda & Helen Inc. and Operator Justin A. Libby were charged jointly and severally under the Magnuson-Stevens Act with fishing outside the Northern Gulf of Maine scallop management area. A \$7,066 NOVA was issued.
